	Audit of Accounts
3	LLPs whose annual turnover exceeds ₹ 40 lakh or whose contribution exceeds ₹ 25 lakh are required to get their accounts audited by a qualified Chartered Accountant mandatorily.
4	LLP Annual Return Within 60 days from the closure of a financial year i.e. 30th May of every year
	Mandatory, heavy penalty of Rs.100 per day of default with no ceiling on the maximum fine
5	Filing Annual Accounts or Statement of Accounts or P&L and Balance Sheet
5	Within 30 days from end of six months of close of financial year i.e. 30th October of every year
6	Income Tax Returns (Company), annually.
7	Income Tax Returns (for Partners), annually.
