<u>Start-up</u> <u>Recognition</u>

The keyword is **innovation**, thus a **business** would **either develop a new product/ service or redevelop a current product/service into a better product.**

<u>Definition of</u> <u>Start-up</u>



The term 'start-up' or "start-up company" means a private company incorporated under the Companies Act, 2013 or the Companies Act, 1956 and recognised as start-up in accordance with the notification issued by the Department of Industrial Policy and Promotion, Ministry of Commerce and Industry"

Who is Eligible to be recognised as a Start-up:

- A Private Limited Company, or
- A registered Partnership Firm
- A Limited liability partnership
- Turnover not exceeding INR 100 Crores (in any of the previous financial years)
- An entity shall be considered as a startup up to 10 years from the date of its incorporation
 - Object of the business— to work towards innovation, improvement of existing products, services and processes, have the potential to generate employment.

<u>Documents required</u> <u>for Start-up</u> <u>Registration</u>

- Incorporation/Registration Certificate of your startup
- Details of the Directors/Designated Partners/ Partners
- Proof of concept like pitch deck/website link/video (in case of a validation/ early traction/scaling stage startup)
- Patents or Trademark details if any

Tax Exemption allowed to Start-up

- Exemption from tax on long term capital gain u/s 54EE.
- Tax exemption on investments above the fair market value.
- Tax exemption to Individual/HUF on investment of long-term capital gain in equity shares of Eligible Start-ups u/s 54GB.
- Set off, carry forward loss and capital gains allowed in case of a change in Shareholding pattern.
