FEES

The cost of registering a trademark range between Rs. 4500 and Rs. 9000. The cheaper trademark cost of Rs. 4500 is available to small businesses, startups, proprietorships, and individuals. The trademark government cost is Rs.9000 for all other entities. The applicant must present an Udyog Aadhar registration certificate in order to be categorized as a small business.
